- **May 2, 2013** - inaugural meeting of CHLNet Health Leadership Action Plan working group
- **June 7, 2013** – second meeting of CHLNet working group where health leadership strategy framework developed
- **June 10, 2013** - National Health Leadership Conference Focus Group in Niagara Falls where strongly agreed there was a need for a national health leadership strategy
- **Summer 2013** - First draft working paper build on the five pillars outlined in the framework
- **October 1, 2013** – Third teleconference of CHLNet working group to discuss progress and review paper
- **October 2013** - Consultation with CHLNet network partners on working paper to mid-November
- **November 28, 2013** – Fourth teleconference of CHLNet work group to review draft paper
- **December 11, 2013** – Working paper reviewed by network partners at CHLNet Roundtable in Ottawa
- **January 14, 2014** – Fifth teleconference of CHLNet working group with finalized working paper reviewed for Montreal Health Leadership Forum (co-sponsored with CFHI and CAHSPR)
- **February 5, 2014** – Letter to Chair of Deputy Ministers (Janet Davidson) on what CHLNet is doing and request to present to DMs in the fall
- **February 14, 2014** - Montreal Health Leadership Forum where working paper presented
- **March 4, 2014** - McMaster Deliberative Dialogue on fostering leadership in health system change. Policy brief done in January by McMaster where took in findings from the working paper, CIHR PHSI Study and Benchmarking Report
- **April 22, 2014** – Sixth teleconference of CHLNet working group to discuss letter to Chair of Deputy Ministers and Committee on Health Workforce asking to present, and follow up from Montreal
- **May 14, 2014** - NPs Roundtable final approval of action plan
- **May 29, 2014** – Seventh teleconference of CHLNet working group to discuss NHLC breakfast session and ask for Committee on Health Workforce
- **June 2, 2014** - Presentation at NHLC breakfast session on action plan
- **June 9, 2014** – Eighth meeting of CHLNet working group to finalize presentation and briefing note to Committee on Health Workforce
- **June 24, 2014** - Committee on Health Workforce where Chair of Working Group (Gillian Kernaghan) and Executive Director (Kelly Grimes) presented action plan in Halifax

- **September 2014** – Summer survey of network partners where advocacy around the action plan rated highly (85% rated very or highly important) to CHLNet’s future
- **October 2014** – Committee on Health Workforce discusses CHLNet action plan and decides each member to discuss with their DM for support
- **October 5, 2014** – DM Bob Bell meet with Chair of Working Group, Executive Director and West Champion (Chris Eagle) to discuss action plan.
- **October 21, 2014** – Conference on Health Workforce – health leaders as part of planning, policy and research
- **October 23, 2014** – First meeting of CHLNet Research and Evaluation Working Group with health leadership action plan at foundation of its activities. Second meeting December 16 with CIHR brief prepared
- **November 6, 2014** – First meeting of CHLNet Knowledge Mobilization Working Group where action plan plays a key foundational piece as develop KM action plan. Second meeting January 29th
- **December 2, 2014** – British Columbia Regional Dialogue Session at Royal Roads University with intention to generate individual and collective commitments to action around health leadership in order to improve overall system performance. Based on health leadership action plan. Report produced for further action in BC (end of January 2015)
- **December 11, 2014** – Conference of Deputy Ministers meet – DM Meade brings topic of health leadership to the table where there was no support or agreement to address leadership at this time or with CHLNet on the proposed action plan. No specific ask brought to table
- **February 2, 2015** – Ninth teleconference of Working Group to discuss next steps and membership
