He is a clinical leader who has been working to promote quality and safety in healthcare since 2001. Dr. Limo worked as a Quality and Safety Officer at Clinica Internacional from 2007 to 2009, where he led an initiative-taking team and launched an institutional project in quality and patient safety. His greatest achievement was the implementation of several strategies of patient safety paving the way for the process which culminated with the accomplishment of the accreditation in 2014 by the Joint Commission International.

He founded New Medical Leaders in 2019, an organization dedicated to developing clinical leaders and fostering change agents for the transformation of healthcare delivery and has organized several national workshops about clinical leadership.

Dr. Limo has participated as an international speaker in Latin-American forums in Argentina, Colombia and Chile and virtually in meetings in Panama, Spain and Germany during COVID pandemic. He has been a key contributor in Peru to organize and drive the Quality and Safety National Movement, having been elected in 2021 – 2023 President of the Quality in Healthcare Association of Perú. Currently, he leads the Quality and Safety National Committee at Peruvian Medical College since 2023.

Lydia Okutoyi is a clinician by background. I am an obstetrician-gynaecologist who has worked in the public sector most of my career. My current Position is director of Health Care Quality (HCQ) at Kenyatta National Hospital, Nairobi, Kenya. Lydia is the founding President of the Society for Quality Health Care in Kenya (SQHK), a multidisciplinary professional association whose aim is to foster quality and patient safety conservation at the hospital, academic, and national levels. At the National level, Lydia is a member of the Quality of Care and Standards, Patient Safety Technical Working Group (TWG). She supports the Kenya Medical and Practioniors Council (KMPDC) and the Pharmacy and Poisons Board (PPB) as a patient safety expert and for policy review/development.
